CONSTRUCTION PERMIT APPLICATION REQUIREMENTS

1. Application for Construction permit must be completed in full or it will be returned to applicant. The fee for the permit application is \$25.00 and is non-refundable.
2. One (1) set of scaled plans must accompany the application. Plans must be drawn to scale showing all visible structures, property lines, right-of-way widths, existing pavement width, utility poles and associated numbers, nearest intersection streets or dimension thereto, north arrow, and any other pertinent information.
3. All Contractors proposing to do work within the Town must have a “Right-Of-Way Construction License” prior to the Construction Permit being issued. Applications and requirements for said license may be obtained from our website or the Public Works Department.
4. All completed application forms must be returned to the Department of Public Works, 260 Westmoreland Street, Narragansett, RI 02882. Hours of operation are Monday thru Friday, 7:00 am to 3:30 pm.
5. A refundable cash deposit is required for all permits where the right-of-way road surface will be impacted. The amount of said deposit and terms of refund will be determined up review of the application and plans. Generally, the fee will be \$25.00 per foot of length of cut in the road with a minimum fee of \$500.00 The Town’s policy is to reimburse 2/3rds upon completion and inspection of work, and then the remaining 1/3rd is to be reimbursed 24 months later, provided there is no additional work required.

NOTE: A copy of Chapter 17 (Road Construction Ordinance) is available for review at the Public Works Department or in the Engineering Department (located at Narragansett Town Hall, 25 Fifth Ave, Narragansett, RI 02882). All work permitted must be in conformance with the ordinance.

No permits will be issued for openings, cuts or excavation of newly paved roads for a period of three (3) years after the completion of said paving.
