**IMPORTANT DATES**  
**SEPTEMBER 13, 2016 PRIMARY**  
**NOVEMBER 8, 2016 GENERAL ELECTION**

**SEPTEMBER PRIMARY**

- JUNE 15**                    **DISAFFILIATION-PRIMARY VOTERS**  
Last day for voters to disaffiliate at their local board of canvassers in order to vote in a different party's primary. Voters must disaffiliate at least 90 days prior to a primary. Unaffiliated voters may vote in any party's primary.
- JUNE 27, 28 & 29**        **DECLARATIONS**  
Declarations for Candidacy for General Assembly, Local Offices, District Committees and Local Committees are to be filed with the Local Board of Canvassers. (Federal and Independent Candidates are to be filed with the Secretary of State.)
- JUNE 30**                    **ENDORSEMENTS-LOCAL/DIST COMMITTEES**  
Endorsements - District Committees/Town Committees to file with Local Boards list of candidates having committee endorsements.
- JULY 1**                     **ENDORSEMENTS-BY STATE WHEN LOCAL/DIST FAILS TO DO SO**  
Endorsements - State Committees to file endorsement with Local Boards when District Committees/Town Committees fail to do so.
- JULY 6**                    **NOMINATION PAPERS-PICK UP AT LOCAL BOARD**  
Nomination Papers - General Assembly, Local Offices, District Committees and Local Committees Candidates can obtain nomination papers from the Local Board of Canvassers. (Federal and State Candidates can obtain nomination papers from the Secretary of State.)
- JULY 15**                  **NOMINATION PAPERS-LAST DAY**  
Nomination Papers - Completed  
All Candidates are to submit completed nomination papers to the Local Board of Canvassers.
- JULY 18**                  **WITHDRAWAL OF CANDIDATES FOR LOCAL OFFICES**  
Final date for local candidates to file withdrawals of candidacy. File withdrawal where nomination papers were filed.
- OBJECTION TO NOMINATION PAPERS - LOCAL CANDIDATES**  
Final date to file objections to eligibility of candidates or sufficiency of nomination papers for local offices. File with Local Board next business day after filing of nomination papers.
- JULY 20**                  **BOARD OF CANVASSERS MEETING**  
Decisions on Nomination Papers
- AUGUST 14**                **LAST DAY TO REGISTER**  
Final date to register to vote for the September 13, 2016 Primary. Registration must be made at least 30 days prior to the primary. (Forms will be available at the Narragansett Police Department)
- AUGUST 23**                **MAIL BALLOT APPLICATION DEADLINE**  
Final date for Local Board to receive mail ballot applications for the September 13, 2016 Primary.
- BOARD OF CANVASSERS MEETING**  
Board to meet to canvass and correct the list of qualified voters.

- AUGUST 24**            **EMERGENCY BALLOTS AVAILABLE**  
Emergency Ballots applications available for those voters whose circumstances manifested twenty (20) days or less prior to the election.
- SEPTEMBER 12**        **EMERGENCY BALLOT DEADLINE**  
Final date for Local Board to receive emergency ballot applications for the September 13, 2016 Primary
- SEPTEMBER 13**        **PRIMARY ELECTION**  
**7:00 A.M. TO 8:00 P.M.**
- SEPTEMBER 14**        **RECOUNTS**  
Recount Requests  
Final date for candidates to request Board of Elections to conduct a recount.  
Must be filed no later than 4:00 PM the day following the Primary.

**GENERAL ELECTION**

- OCTOBER 9**            **LAST DAY TO REGISTER**  
Final date to register to vote for the November 8, 2016 General Election. Registration must be made at least 30 days prior to the primary.
- OCTOBER 18**          **BOARD OF CANVASSERS MEETING**  
Board to meet to canvass and correct the list of qualified voters.
- OCTOBER 18**          **MAIL BALLOT APPLICATION DEADLINE**  
Final date for Local Board to receive mail ballot applications for the November 8, 2016 General Election.
- OCTOBER 19**          **EMERGENCY BALLOTS AVAILABLE**  
Emergency Ballots applications available for those voters whose circumstances manifested twenty (20) days or less prior to the election.
- NOVEMBER 7**          **EMERGENCY BALLOT DEADLINE**  
Final date for Local Board to receive emergency ballot applications for the November 8, 2016 General Election.
- NOVEMBER 8**          **GENERAL ELECTION**  
**7:00 AM TO 8:00 P.M.**
- NOVEMBER 15**        **RECOUNTS**  
Recount Requests  
Final date for candidates to request Board of Elections to conduct a recount.  
Petition to be filed within 7 days after election.
