1. Worked on administrative tasks, organized files, and fielded calls for the following: renewals, waiting list inquiries, and general mooring information.
2. The harbormaster boat was launched and is in full service.
3. The Narrow river patrol boat is ready for launch pending dock availability at the Mettatuxet Yacht club.
4. The Point Judith patrol boat is in a ready status to be launched at short notice if needed.
5. Mooring inspections in area "B" are ongoing. The weather has not been good for our "on deck" inspections however I am hopeful that they will be completed by June 1st.
6. As of April 30th, one month past the due date we have 3 moorings with no response at all, 12 that have not provided proof a valid registration, 6 who stated the check is in the mail and 4 cancelled.
