- **Item A1, Minutes:** Content of minutes from 2023-Sep-05 was reviewed and received correction commentary, noted by Secretary. Moved by Rick Black, seconded by John Hughes to accept minutes as thereby corrected. Motion passed 5-0 (Secretary Berry abstaining, Ray Morrocco was not present Sep-05 and therefore abstained).
- **Item B1, Harbormaster Report:** Report from 2023-Sep-30 was reviewed and discussed. Moved by Ray Morrocco, seconded by Rick Black to accept report as submitted. Motion passed 7-0.

Old Business

- **Item C1, Point Judith Pond Closures / Water Quality:** No data from test sites available as yet. It was noted the Champlin/Long Cove 6 testing sites are currently being sampled by Water Quality subcommittee and forwarded to test lab. Total of 3 sample dates have been processed and we expect 3 more in future. The NHMC considers the resultant analysis data as worthy of review at future meetings and recommends continued placement of this item on the agenda.
- **Item C2, Harbor Management Plan (HMP):** Noted that Planning Tech Ryan DePanni has been providing helpful office support. With this help ongoing, the HMP subcommittee expects to have the draft update ready for full NHMC review, possibly next month. The NHMC considers this process as positive and justifies continued placement of this item on the agenda. Further agreement reached that the general progression of the HMP update remain as agreed earlier: 1. Markup completed, 2. NHMC as whole reviews document, 3. Forward to RI CRMC (Kevin Cute) for review, 4. Forward to Narragansett Town Council.

Items for next agenda: (in addition to Old Business Items C1 and C2 cited above): Stormwater discharge from the area of the Harbour Island community dock is deemed problematic.
